# February 1 & 2, 2008 Official Tournament Information

DATE: February 1&2, 2008

Weigh-in on Friday February 1 from 3:00 p.m. – 7:00 p.m. Wrestling on Saturday February 2 starting at 8:00 a.m.

#### RULES:

Modified National Federation High School rules (minimum rest between matches and maximum number of matches in a day NOT in effect) Hair code and fingernails will be enforced by referees. Hair cover (if required) must be with wrestler at weigh-in. Headgear required for 15 and under division only.

#### SITE:

Sevier Valley Center, Richfield, Utah Weigh ins at the East entrance. Go west on 100 South to the end of the street.

#### **ENTRY DEADLINE:**

On-line registration will close at midnight January 26, 2008 NO LATE ENTRIES WILL BE ACCEPTED - DO NOT ASK Must make weight as entered. No changes after deadline.

#### REGISTRATION INFORMATION:

Registration must be done on-line at **utahnationals.com or trackwrestling.com**The entry fee is \$22.00
No USA card required.

#### **COACHES FLOOR PASS: \$10.00**

1 pass will be given per team for first five entries, three passes for the first ten entries, 1 pass for each additional five entries.

### FORMAT:

Folkstyle (collegiate style). Double Elimination – Challenge for second format. Referee decisions final. All match protests to be directed to tournament directors along with a \$35 protest fee. All age protests must be made before third match. Birth certificates must be available.

**6 & Under** - Must not be 7 before 9/1/07 37, 40, 43, 46, 49, 52, 55, 60, 61-70 LT HWT, 71 & up HWT

8 & Under - Must not be 9 before 9/1/07

43, 46, 49, 52, 55, 58, 61, 64, 67, 70, 75, 85, 86-100, 101 & up

10 & Under - Must not be 11 before 9/1/07

52, 55, 58, 61, 64, 67, 70, 73, 76, 80, 85, 90, 100, 110, 111-131, 130 & up

12 & Under - Must not be 13 before 9/1/07

64, 67, 70, 73, 76, 80, 84, 88, 92, 96, 100, 105, 110, 120, 130, 146-160, 161 & up

**15 & Under** - Must not be 16 before 9/1/07 AND must not be wrestling with a high school program. 75, 82, 89, 95,101,108,114,120, 126, 132, 138, 145, 157, 175, 200, 275

**WEIGH-INS:** Friday, February 1, 2008 3:00-7:00 p.m. at the Sevier Valley Center (east entrance). Each wrestler may wrestle in one division only. No moving up in weight. NO ADDITIONAL WEIGH IN.

STATE ISSUED BIRTH CERTIFICATES REQUIRED IF REQUESTED BY TOURNAMENT OFFICIALS. NO HOSPITAL CERTIFICATES ACCEPTED.

**TIME PERIODS**: 6-8 & Under – 1 -1 -1 including finals. 10, 12, 15 & under divisions – 1 1/2 - 1 1/2 - 1 1/2 including finals. Consolations – 1 - 1 - 1. Overtime – One minute then 30 seconds tie breaker if needed.

**NO SEEDING:** Every effort will be made to separate wrestlers from the same team.

**AWARDS:** Medals 1st through 6th, Outstanding Wrestler Trophy in EACH division based on champion with most falls (including technical falls) in the least amount of time. Team Trophies – Team with most points based on point system. 14-10-7-4-2-1 is champion. If tied, next criteria is most champions. Must wrestle for your own team. Teams to be considered for team competition must submit all wrestlers names on one entry form. Must be present to win. All star teams cannot compete for team awards.

This is a National Tournament. So Absolutely no Late Entrees or Phone-Ins will be Accepted. This event is growing at a rapid pace so entries will be limited to the first 1,000. Don't get left out!
